- 1. Concurrent with the filing of this Motion the Applicant is filing its Application for certification to provide intrastate telecommunications services in Kansas. As part of that Application, the Applicant has produced and will file a profit and loss statement and balance sheet as Exhibit A to the Application. The information contained in those documents is confidential, not publicly issued by the Applicant, and contains sensitive information that would be of value to competitors.
- 2. Under K.A.R. 82-1-221a(5)(b) the Applicant seeks confidential treatment of the financial information pursuant to this Motion. The potential harm presented by disclosure of the documents is that competitors could determine the scope of the Applicant's present and anticipated investment in its Kansas City telecommunications operation, allowing competitors to change their investments in such services to maximize their competitive advantage.

3. The Applicant's is filing two versions of its Application: a public version with Exhibit A redacted and a confidential version with Exhibit A included.

WHEREFORE, the Applicant requests the Commission grant the Applicant's Motion to file the financial statements contained in Exhibit A to its Application under seal and that they not be publicly available in the Commission's records.
