PREHEARING OFFICER ORDER SETTING PREHEARING CONFERENCE

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having reviewed the pleadings and record, the Prehearing Officer makes the following findings:

- On April 25, 2019, the Commission issued a *Penalty Order* against Micro Oil, LLC 1. (Operator) for seventeen violations of K.A.R. 82-3-409 because Operator failed to file annual fluid injection reports for seventeen wells in Allen County.¹
- On May 28, 2019, Operator requested a hearing.² On June 6, 2019, the Commission 2. issued an order setting a June 21, 2019, prehearing conference.³
- 3. At the June 21, 2019, prehearing conference, the parties agreed to set a new prehearing conference for July 12, 2019, with the anticipation that in the interim parties would discuss the possibility of a resolution prior to the development of a procedural schedule, and that Operator would obtain counsel if necessary.
