**NOTICE OF FILING OF ANNUAL GAS SUPPLY PLAN**

Kansas Gas Service, a division of ONE Gas, Inc. (“Kansas Gas Service” or “Company”) respectfully files its annual Gas Supply Plan in accordance with the Order issued by the State Corporation Commission of the State of Kansas (“Commission”) on June 21, 2001, in Docket No. 106-850-U / 75-GIMC-009-GIG (“Order”). In support thereof, Kansas Gas Service states the following to the Commission:

**I. DESCRIPTION OF KANSAS GAS SERVICE**

1. Kansas Gas Service is a natural gas public utility operating in the State of Kansas pursuant to certificates of convenience and necessity issued by the Commission. Kansas Gas Service’s principal place of business is located at 7421 West 129th Street, Overland Park, Kansas 66213.

**II. NATURE OF FILING**

2. Pursuant to the Order, each jurisdictional natural gas public utility is required to meet with Commission Staff, at a time determined by Staff, at least once per year to discuss the utility’s gas portfolio and plans for the next year.<sup>1</sup> As required by the Order, the filing of the annual Gas Supply Plan must be submitted at least 14 days prior to the meeting. This plan must

include written documentation which details the utility's current situation, its plans for the next 12 months, and its performance during the prior year.<sup>2</sup>
