Dear Ms. Retz:

On June 6, 2023, MCMC and Kansas Gas Service, a division of ONE Gas, Inc. ("KGS"), filed a joint application with the Kansas Corporation Commission ("Commission") to respectively cease operating the 1204 Pipeline, an approximately 18.4 mile, twelve-inch, natural gas pipeline located in Kingman County, Kansas, and for permission to cease providing service to five farm tap customers served from the natural gas pipeline ("Application").

On December 28, 2023, the Commission issued its Order Cancelling Certificate and granting MCMC's request to cease operating the 18.4 mile pipeline located in the Kingman County, Kansas.

The purpose of this letter is to clarify for the record in this docket that the physical 14-inch natural gas line MCMC internally refers to as the "1401 Pipeline" was included in the 18.4 miles of pipeline identified in paragraph 2 of the Application, shown in the map attached to the Application as Exhibit A, and included in the legal description in paragraph 4 of the Commission's Order Cancelling Certificate, even though the 1401 Pipeline was not specifically mentioned by number in the Application. MCMC's 12-inch 1204 Pipeline, which is specifically mentioned in the Application and the Order Cancelling Certificate, makes up approximately 16 miles of the total 18.4 mile pipeline that was abandoned. MCMC's 14-inch 1401 Pipeline makes up the remaining approximately 2.3 miles abandoned under the Order Cancelling Certificate.
