ORDER SETTING PROCEDURAL SCHEDULE

- 1. On May 1, 2018, Victory Electric Cooperative Association, Inc. (Victory) filed its Application seeking approval to make changes to its Local Access Delivery Service (LADS) charge assessed to wholesale users of Victory's 34.5kV system.¹ The filing was made in accordance with the 34.5kV Formula Based Rate (34.5kV FBR) plan established and approved by the Commission in Docket No. 16-MKEE-023-TAR.²
- On May 4, 2018, William G. Riggins entered his appearance on behalf of Kansas 2. Electric Power Cooperative, Inc. (KEPCo).
- 3. On May 9, 2018, Victory, KEPCo, and Commission Utilities Staff (Staff) (collectively, Joint Movants) filed a Joint Motion for Procedural Order, recommending an agreed schedule to the Commission for its review and approval.
