## MOTION TO DISCONTINUE REPORTING REQUIREMENT

Kansas Gas Service, a division of ONE Gas, Inc. ("Kansas Gas Service"), respectfully requests that the State Corporation Commission of the State of Kansas ("Commission") discontinue the requirement to report the amount of cast iron pipe remaining in its system. In support of this motion, Kansas Gas Service states the following to the Commission:

- 1. On September 13, 2012, in Docket No. 12-KGSG-721-TAR, the Commission ordered Kansas Gas Service to "annually file a brief summary or chart showing the amount of cast iron pipe remaining in its system." Order Denying Kansas Gas Service's Application for Infrastructure Replacement Program Surcharge, ¶ 30. This report is required to be filed by March 1 each year. Order Granting Kansas Gas Service's Petition for Reconsideration, Docket No. 12-KGSG-721-TAR, p. 2 (Oct. 19, 2012).
- 2. Kansas Gas Service's annual cast iron compliance filings are made in Docket No. 13-KGSG-538-CPL. As shown in the last compliance filing on March 1, 2024, and the latest report attached hereto as Attachment A, Kansas Gas Service has replaced all known cast iron in its system. Therefore, the annual reporting requirement has fulfilled its purpose and may be discontinued.

WHEREFORE, Kansas Gas Service respectfully requests that the Commission terminate the annual cast iron reporting requirement and grant any other relief deemed just and reasonable.
