MOTION FOR 7-DAY EXTENSION TO STAFF'S DIRECT TESTIMONY DEADLINE

Commission Staff (Staff) of the State Corporation Commission of the State of Kansas (Commission) files this Motion for a seven-day extension to its pre-filed direct testimony deadline. In support of its Motion, Staff states as follows:

- 1. On June 19, 2017, Staff denied Operator's license renewal application. Operator timely appealed. The matter has been set for a January 18, 2018, evidentiary hearing. Staff's direct testimony is currently due today, Operator's testimony is due December 29, 2017, and rebuttal testimony is due January 8, 2018.
- 2. There is only one well record that still needs to be resolved for this matter to be fully resolved, and the well in question is scheduled to be dug up this week to determine whether it is plugged. If it is plugged, there is no need for a hearing. Staff would like to delay its pre-filed testimony deadline to December 19, 2017, potentially avoiding the need to file such testimony. Staff has spoken with Operator's counsel, who is not opposed.

WHEREFORE, Staff requests this motion be granted.


