Having examined its files and records, and being duly advised in the premises, the Commission finds as follows:

- 1. On March 23, 2011, the Commission entered its Order Adopting Procedural Schedule and Granting Intervention to CURB.
- 2. Due to a scrivener's error, the first sentence in paragraph 12 of the March 23, 2011 Order erroneously makes reference to "April 7, 2011" as the date for the public hearing in the above-captioned docket, when the reference should be to "April 20, 2011." Consequently, the sentence should read: "The Commission adopts the recommendation to conduct a public hearing on April 20, 2011, beginning at 6:00 p.m."
