#### **ORDER APPROVING APPLICATION**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the file and records, and being properly advised, the Commission finds:

#### I. Background

1. On May 1, 2017, Victory Electric Cooperative Association, Inc. (Victory) filed an Application for the purpose of updating its Local Access Delivery Service (LADS) tariff.<sup>1</sup> Victory seeks to implement an increase to the LADS demand charge assessed on the wholesale users of its 34.5kV system from \$2.99 per kW to \$3.16 per kW in accordance with the 34.5 kV Formula Based Rate Plan approved in Docket No. 16-MKEE-023-TAR.<sup>2</sup>

2. On May 5, 2017, the Kansas Electric Power Cooperative, Inc. noted its participation in this docket through the filing of William G. Riggins' Entry of Appearance.<sup>3</sup>

3. On August 29, 2017, Commission Staff (Staff) filed its Report and Recommendation.<sup>4</sup> Staff recommended that the Commission approve Victory's proposed monthly LAC rate of \$3.16 per kW-month.<sup>5</sup> Staff noted that the Application's proposed rate increase of 5.7% was largely caused by increases in transmission plant depreciation expense, other deductions, and principal payments from the 16-VICE-494-TAR Docket to this present docket.<sup>6</sup>

4. Staff also recommended additional disallowances of 50% of an expense related to an annual subscription, 100% of expenses related to promotional mailings, and an additional 50% of expenses related to sponsorship were appropriate.<sup>7</sup> However, Staff noted these adjustments would not have any effect on the final revenue requirement and, consequently, no effect on the final LAC rate.<sup>8</sup>

#### II. Findings and Conclusions

5. The Commission finds that there is an ample record from which to make a decision. Victory filed the Direct Testimony of Elena E. Larson and Shane Laws in support of its Application. Staff filed its Report and Recommendation in support of the Application.

6. The Commission finds that the terms of the Application, and specifically, the demand charge assessed on wholesale users of Victory's 34.5 kV system are in conformity with the just and reasonable standard. The Commission has reviewed Staff's recommended disallowances and finds them to be appropriate. Therefore, the Commission finds the Application should be approved.
