### ORDER DESIGNATING PRESIDING OFFICER

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. The Commission finds the following:

- 1. On February 28, 2022, NextEra Energy Transmission Southwest, LLC (NEET) filed an Application for a Certificate of Public Convenience and Necessity to transact the business as a transmission-only public utility in Kansas, and to construct, own, operate and maintain bulk electric transmission facilities located in the State of Kansas.<sup>1</sup>
- 2. The Commission may designate a presiding officer to conduct prehearing conferences to address any matters appropriately considered in a prehearing conference, including all items listed in K.S.A. 77-517(b) of the Kansas Administrative Procedure Act (KAPA).
