**JOINT MOTION FOR ORDER ESTABLISHING PROCEDURAL SCHEDULE**

COME NOW Evergy Kansas Central, Inc. and Evergy Kansas South, Inc. (collectively “Evergy Kansas Central” or “EKC”), along with Staff of the State Corporation Commission of the State of Kansas (“Commission Staff”) and the Citizens’ Utility Ratepayer Board (“CURB”), and file this Joint Motion for Order Establishing Procedural Schedule. In support hereof, the joint movants state as follows:

1. On January 31, 2025, EKC filed a Joint Application requesting authorization to make certain changes to its charges for electric service in Kansas pursuant to K.S.A. 66-117 and K.A.R. 82-1-231. The Joint Application requests that the proposed rate changes become effective in accordance with the above-cited authorities.

2. EKC, Commission Staff, and CURB have discussed the schedule under which the Joint Application should be considered and, based on those discussions, request the following procedural schedule be established:
