APPLICATION

COMES NOW the Applicant, Suburban Water, Inc., d/b/a Suburban Water Company ("Suburban Water" or "Applicant"), and pursuant to K.S.A. 66-117, 66-1,230, 66-1,232, 66-1,233, and the Kansas Corporation Commission's ("Commission") Rules of Practice and Procedure, states as follows:

- 1. Applicant is a corporation duly organized under the laws of the State of Kansas, and has its principal place of business at 1216 N. 155th Street, Basehor, Kansas 66007.

- 3. Applicant is duly authorized to transact business in the State of Kansas, holds appropriate certificates from this Commission to transact business as a water public utility, and is now and has been engaged in the purchase, transmission, sale and distribution of water in the State of Kansas in accordance with the laws of said State and the Rules and Regulations of this Commission. Applicant provides retail water service to approximately 1,500 residential and small commercial customers in Leavenworth County, Kansas. Applicant also provides wholesale water service to Rural Water District No. 10 in Leavenworth County, Kansas.
- 4. Suburban Water currently purchases approximately sixty percent (60%) of the water that it supplies to its retail and wholesale customer from the Kansas City, Kansas Board of Public Utilities ("BPU"). Since Suburban Water's last rate filing in 2007 (Docket No. 07-SUBW-1352-RTS), BPU has increased the rate it charges Suburban Water for its water supply several times. In addition, BPU has recently announced it intends to increase the rate it charges Suburban Water by nearly 30% incrementally over the next five year period starting in 2010 (8.0% in 2010; 8.0% in 2011; 7.5% in 2012 and 7.5% in 2013). Suburban Water does not currently have a purchase cost adjustment provision in its tariffs like gas and electric utilities that would allow it to recover these proposed increases in its water supplies without filing a rate case. Given Suburban Water's relatively small size (less than 1,500 customers), it is not practical to file a rate case each time its wholesale water supply costs are increased by BPU. This is especially true given BPU's announcement it plans to have a 7.5% to 8% increase in rates charged to Suburban Water for each of the next five years. Accordingly, Suburban Water is requesting permission to implement a purchased water cost adjustment ("PWA") similar to the purchased gas adjustments currently approved by natural gas utilities regulated by the Commission.

- 5. The purchased water adjustment clause Suburban Water is requesting be approved is attached hereto as Appendix A and incorporated herein by reference. This clause has been designed with the objective of allowing cost recovery (or return) to occur in the same period during which charges in prices paid for water occur. This is accomplished by establishing on June 1 of each year an estimated total cost for purchased water for the ensuing 12 months.
- 6. Under this clause, the estimates will be based on known changes in wholesale water rates as specified in contracts in effect on the estimating date, and estimated changes in volumes of water from each supplier. The estimated costs include the cost of water, the cost and unaccounted for water, and any cost incurred in administering wholesale water contracts, including rate case expense incurred in intervention of any wholesale supplier's rate case, on behalf of Suburban Water and its customers.
- 7. Once the total estimated cost of purchased water for the forecasted year is determined, such cost is divided by the amount of water estimated to be sold during the same period to produce an estimated effective cost per 1,000 gallons. Such calculation provides a forward-looking, weighted average cost of water which can be compared to the cost of water during the base period to arrive at the net purchased water adjustment. During the ensuing 12- month period, the adjustment may be recomputed if unforeseen changes result in a change in the average cost of water for the 12-month period of one mill or more per 1,000 gallons.
- 8. The purchased water adjustment clause includes a variable line loss factor, which will not exceed a limit to be calculated on the most recent 12-month period ended June 30 or the established limit value, whichever is less. The clause also provides for a settlement calculation to be made annually, by comparing costs recovered through the clause to actual costs incurred. The clause

will allow the Commission to reserve the right to require an earlier settlement if over- or underrecoveries are excessive. The settlement amount would be returned to or recovered from customers by incorporating a settlement factor, in cents per 1,000 gallons, into the PWA clause during the succeeding 12-month period.

- 9. The proposed purchased water adjustment clause does not contain a provision for the assessment of Suburban Water due to estimating inaccuracies that result in excessive over-recoveries. However, the proposed tariff will allow the Commission to review annually the net over- or under-recovery by Suburban Water and where over-recovery is excessive, interest can be ordered to be paid on the refund thereof.
- 10. Suburban Water will submit monthly reports to the Commission for review by its Staff. Such reports will be submitted in the form and manner prescribed by the Commission. The report from Suburban Water will be received by the Commission on or before the 25th day of the month prior to the month for which such utility's purchased water adjustment is to be billed.
- Staff to develop and implement a monitoring and auditing system to insure the proper implementation of the purchased water adjustment clause prescribed by this application. As part of the audit procedure, Suburban Water agrees to submit to this Commission, within fifteen (15) days after execution, every water purchase contract together with a statement of other alternatives for obtaining the necessary water and the reasons for selecting the alternative embodied in the contract. This provision shall apply to all new contracts and to all existing contracts which are either renewed or renegotiated. Suburban Water also agrees that within 15 days following notification from its water supplier, it will provide to the Commission a statement of the justification for every escalation invoked

under the terms of its existing contracts.

12. The above referenced contracts will be used only by the Commission and its Staff for

investigative purposes and therefore will be deemed confidential or proprietary documents by this

Commission in order to maintain the integrity of the utility's decision represented by said documents.

The routine filing of such water purchase contracts shall not constitute them to be public documents

as defined by state law except as may be otherwise ordered by the Commission.

13. Suburban Water's proposed PWA calculation, which is attached hereto as Appendix

B, reflects the proposed increase in rates that BPU plans to charge to Suburban Water beginning June

1, 2010. The PWA reflects a change in the BPU charge included in Suburban Water's last rate case

order of \$1.70 per 1,000 gallons base charge and BPU's proposed rate of \$1.77 per 1,000 gallons based

charge, plus a water loss adjustment of 5.29%, for a net increase of \$0.0739 per 1,000 gallons.

14. A proposed PWA tariff is attached hereto as Appendix C for the Commission's review

and approval.

WHEREFORE, Suburban Water requests approval of its purchased water cost adjustment and

for such further relief as the Commission finds necessary.

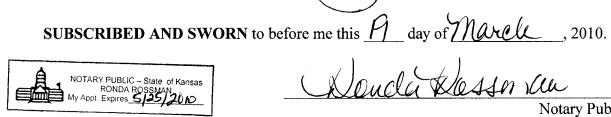

PURCHASED WATER COST ADJUSTMENT CLAUSE

WATER UTILITIES

Rate Schedules Covered: All rate schedules shall be subject to a purchased water cost adjustment.

COMPUTATION FORMULA

The specified service rates are subject to adjustment for change in the average cost of water from all wholesale sources of supply purchased. On June 1 of each year, the company will project the average cost of wholesale water for the 12 months ending June 30 of the following year. If at any time during this 12-month period, the company experiences a change or changes in supplier rates or in sources of supply, the cumulative effect of which change or changes is to produce an increase or decrease in the new projected effective rate for purchased water from all suppliers of at least $0.1 \, \text{¢}$ per 1,000 gallons, then an adjusted average rate shall be determined. The annual cost of water projection and any revised projections throughout the year will be computed using the following formula:

Where:

- P = The estimated total dollar cost of purchased water to be sold calculated by summing the products of the most recent unit cost of purchased water from each wholesale supplier and the estimated unit purchased from each wholesale supplier for the 12-month period ending June 30. In the event that changes in the rates paid for purchased water will take place within the current 12-month period ending Jun 30 as specified by contract provisions currently in effect, the estimated average unit cost of purchased water from each supplier for the current 12-month period ending June 30, may be used in the calculation in place of the cost recent unit cost.
- V = The estimated sales volume in 1,000 gallons for the 12-month period ending June 30.*
- b = Actual purchase water cost in $\phi/1,000$ gallons established during the base period.

^{*}If the actual sales volume reflects a line loss factor greater than the limit value, restatement of sales volume, based on the limit value for line loss, shall be required.

COMPUTATION PERIOD

The computation period shall be the subsequent 12-month period ending June 30.

COMPUTATION FREQUENCY

The computation shall be made annually on June 1, and each time a change or changes occur in supplier rates or sources of supply, the cumulative effect of which change or changes is to produce an increase or decrease in the new effective rate paid for purchased water by at least $0.1 \, \text{\rlap/}e/1,000 \, \text{gallons}$.

SETTLEMENT PROVISION

Subsequent to the effective date of this clause, the company shall maintain a continuing monthly comparison cost of wholesale water as shown on the books and records of the company, exclusive of refunds, and the cost of wholesale water for the same month calculated by applying to the volumes sold during said month the new estimated effective rate $\frac{P}{(0.1) \text{ V}}$ used to determine the purchased

water cost adjustments pursuant to these purchased water cost adjustment provisions. For each 12-month billing period ended June 30, the cumulative differences of the comparisons described above will be added to the "Actual Cost Remainder" described below to produce a cumulative balance of over-recovered or under-recovered costs. An "Actual Cost Adjustment" ("ACA") shall be computed by dividing the cumulative balance of under-recovered or over-recovered costs by the volume of total sales during the 12-month period ending on that date. This adjustment shall be rounded to the nearest 0.0001/per 1,000 gallons and applied to sales billed on or after the first day of the month following the month in which the adjustment has been approved by the Commission. The "Actual Cost Adjustments" shall remain in effect until superseded by subsequent "Actual Cost Adjustments" calculated according to this provision.
