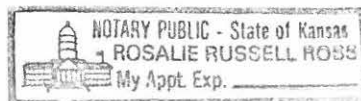

If a protest is not timely filed with the Commission, the Application will be determined administratively by the Commission and may thereby be granted without hearing or further notice to any interested party. The objection or complaint shall state the reasons why an exception to the 10 year time limitation for temporarily abandonment of the Subject Well in the manner and at the location set forth in the Application will violate correlative rights or cause waste.
