**APPLICATION FOR A CERTIFICATE OF PUBLIC CONVENIENCE AND
AUTHORITY TO TRANSACT THE BUSINESS OF AN ELECTRIC PUBLIC UTILITY**

COMES NOW Westar Energy, Inc. (Westar Energy), and in support of its Application
for a Certificate of Public Convenience and Authority, states:

Westar Energy is a Kansas corporation authorized by the Commission pursuant to K.S.A.
66-104 to conduct the business of a public utility, and as such holds a Certificate of Convenience
and Authority from this Commission to engage in the business of an electric public utility in the
State of Kansas, thereby promoting the public convenience.

1. Westar Energy seeks to serve, subject to the Commission's approval, in Kansas
City Power & Light Company (KCP&L) certified territory described below:

JOHNSON COUNTY, KANSAS

A tract of land described as Lots 229-236, 263, 264, 376-383, 415 and 416 in
Woodland Ridge Subdivision of Spring Hill located in the Northwest ¼ of
Section 13, Township 15 South, Range 23 East in Johnson County, Kansas, as
detailed on the map marked Exhibit A and attached hereto.

2. Westar Energy and KCP&L are working together to correct territory issues.

3. KCP&L has agreed to cease serving the tract of land described in Paragraph 1,
subject to the Commission's approval, to correct the existing territory discrepancies.

4. Westar Energy understands that KCP&L has filed, or will soon file, an application with the Commission to cease serving its electric service in the territory described in paragraph 1.



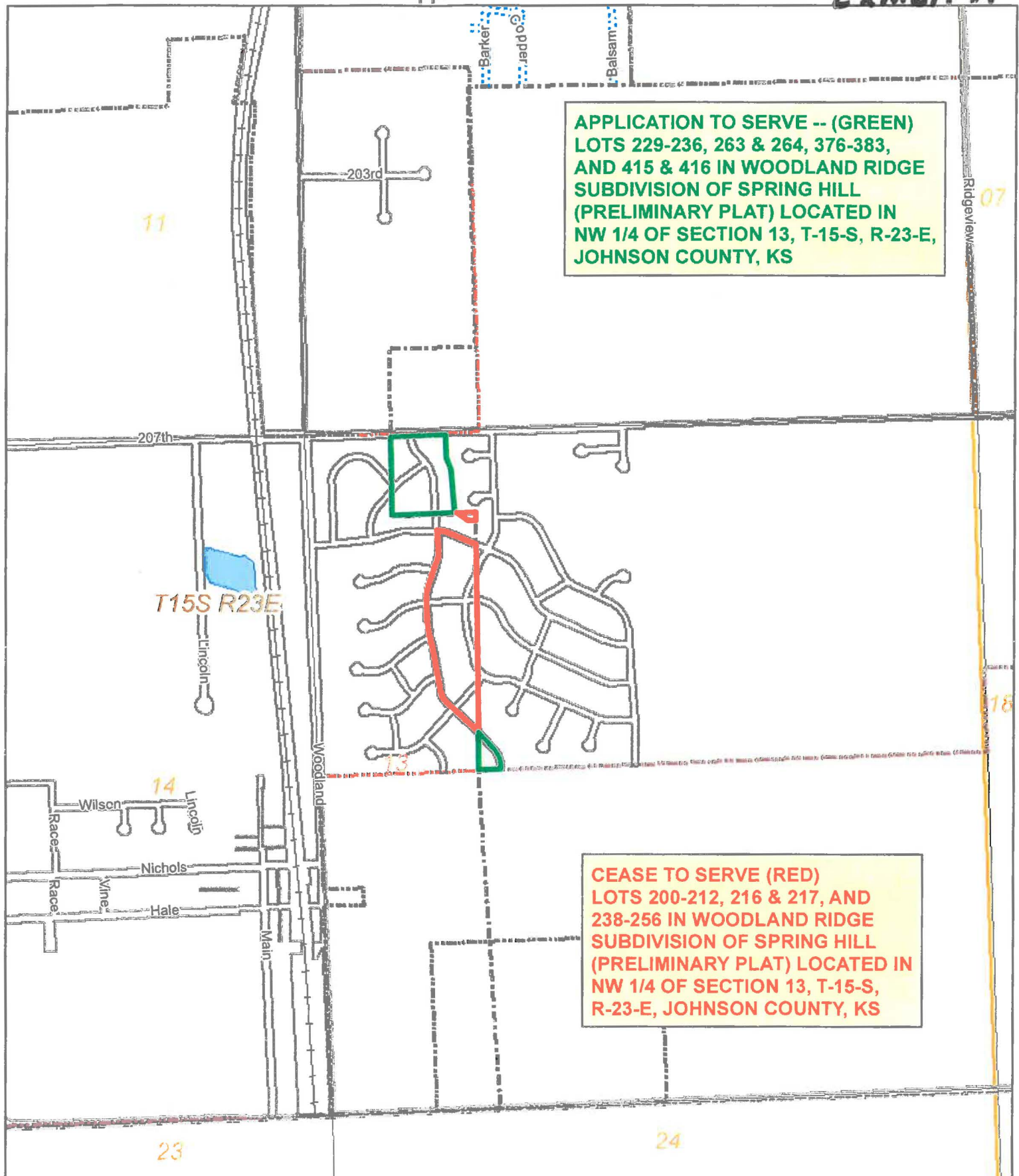
