PETITION TO INTERVENE

COMES NOW the Western Kansas Industrial Electric Consumers Group ("WKIEC") and herby moves the Corporation Commission of the State of Kansas ("Commission") for an Order permitting it to intervene in the above-captioned matter. In support of its Petition, WKIEC states and alleges as follows:

- 1. WKIEC is a voluntary association of Western Kansas industrial consumers which represents the interests of those consumers in utility proceedings. Attached hereto and incorporated herein by reference is a list of those industrial consumers and the individual distribution cooperatives or company that provides them with electric service (Appendix A).
- 2. On July 16, 2015, the applicants, and each of them, filed their joint Application for Commission Approval of individual 34.5 kV Formula-Based Rate.
- 3. WKIEC is requesting permission to intervene in this Docket to represent the interests of the large industrial customers: Cargill, Inc. served by Victory Electric Cooperative Association, Inc.; Linde, Inc. served by Western Cooperative Electric Association, Inc.; DCP Midstream, L.L.C. and Air Products & Chemicals, Inc. served by Southern Pioneer Electric Company. Although the WKIEC members taking 34.5 kV service are retail customers, they pay Local Access charges that will be affected by this filing. Accordingly, they have a justifiable interest in the outcome of this proceeding.

4. The representation of WKIEC's interests in this proceeding by existing parties is or may be inadequate and no party will represent the interests of large industrial customers, except for WKIEC.

5. Large industrial ratepayers, whose interests WKIEC represents, will be bound by any Commission Order or activity in this proceeding and will or may be adversely affected thereby.
