NOTICE OF PENALTY ASSESSMENT

This is a notice of a penalty assessment for violation(s) of Kansas Oil and Gas Conservation Statutes, Rules, and Regulations. For a full description of the penalty and process please refer to the Penalty Order that is attached to this notice.

IF YOU ACCEPT THE PENALTY:

You have been assessed a \$500 penalty. You have 30 days from the service date of this Penalty Order to pay the fine amount. Check or money order must be made payable to the Kansas Corporation Commission and mailed to the Conservation Division of the Kansas Corporation Commission at 266 N. Main St., Suite 220, Wichita, Kansas 67202. The payment must include a reference to the docket number of this proceeding. Payment by credit card may be made by calling the Conservation Division at 316-337-6200.

IF YOU CONTEST THE PENALTY:

You have the right to request a hearing. A written request for hearing must be made within 30 days after service of the Penalty Order setting forth the specific grounds upon which relief is sought. Respondent must submit the request to the Commission, at 266 N. Main St., Suite 220, Wichita, Kansas 67202. The Commission shall conduct a hearing in accordance with the provisions of the Kansas administrative procedure act within 30 days after receipt of such request. K.S.A. 55-164; K.S.A. 77-542; K.A.R. 82-1-215.

IF YOU FAIL TO ACT:

Failure to pay the fine amount, or in the alternative, provide a written request for a hearing, within thirty (30) days of service of the Penalty Order, will result in the attached Penalty Order becoming a Final Order and may result in additional sanctions, including additional monetary penalties, the suspension of your oil and gas operating license, and the shutting-in of all operations until compliance is obtained. K.S.A. 55-164; K.S.A. 77-537.

The above captioned matter comes before the State Corporation Commission of the State of Kansas. Having examined the files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

I. JURISDICTION

1. The Commission has the exclusive jurisdiction and authority to regulate oil and gas activities in Kansas.¹ The Commission has jurisdiction to regulate the "construction, operation, and abandonment of any well and the protection of the usable water of this state from any actual or potential pollution from any well."² Every operator conducting oil and gas activity in Kansas must be licensed by the Commission.³

2. The Commission has the authority to issue a Penalty Order for violation of any provision of K.S.A. 55-101 et seq., rule, regulation, or order of the Commission.⁴ The Commission shall take appropriate action which may include, but not be limited to, imposing a monetary penalty "not to exceed \$10,000, which shall constitute an actual and substantial

economic deterrent to the violation for which the penalty is assessed."⁵ "In the case of a continuing violation, every day such violation continues shall be deemed a separate violation."⁶

3. Each operator of an injection well shall submit a report to the Conservation Division, on a form required by the Commission, showing for the previous calendar year the following information:

a. The monthly average wellhead pressure;

- b. The maximum wellhead pressure;
- c. The amount and kind of fluid injected into each well; and
- Any other performance information that may be required by the Conservation Division.⁷

4. The report shall be submitted on or before March 1 of the following year, and failure to timely file an annual injection report shall be punishable by a \$100 penalty.

II. FINDINGS OF FACT

The Operator is responsible for the care and control of the well(s) listed in Exhibit
A ("the subject wells"), which are authorized injection wells.

6. On July 18, 2018, Commission Staff sent a Notice of Violation letter to the Operator, stating that the Commission was not in receipt of the annual fluid injection report(s) for activity during the 2017 calendar year at the subject well(s). The letter gave an August 1, 2018 deadline for the Operator to submit the report(s) and avoid a penalty.⁸

7. To date, the Operator has failed to file the annual fluid injection report(s) for the subject well(s), reporting activity during the 2017 calendar year.

III. CONCLUSIONS OF LAW

8. The Commission finds and concludes that it has jurisdiction over the Operator and this matter under K.S.A. 55-152 and K.S.A. 74-623.

9. The Commission finds and concludes the Operator committed five violation(s) of K.A.R. 82-3-409 because the Operator failed to file the necessary annual fluid injection report(s) at the subject well(s).

THEREFORE, THE COMMISSION ORDERS:

A. The Operator shall pay a \$500 penalty.

B. The Operator shall file the required annual fluid injection report(s).

C. <u>If no party requests a hearing, and the Operator is not in compliance with this</u> <u>Order within 30 days from the date of service of this Order, then the Operator's license shall be</u> <u>suspended without further notice</u>. The notice and opportunity for a hearing on this Order shall constitute the notice required by K.S.A. 77-512 regarding license suspension. The Commission may impose further sanctions, including additional monetary penalties and any other remedies available to the Commission by law, without further notice.

D. Checks and money orders shall be payable to the Kansas Corporation Commission. For credit card payments, include the type of card (Visa, MasterCard, Discover, or American Express), account number, and expiration date. <u>The payment must include a reference</u> to the docket number of this proceeding. Credit card payments may be made by calling the Conservation Division at 316-337-6200.

E. Any party may request a hearing on the above issues by submitting a written request, pursuant to K.S.A. 55-164, K.S.A. 77-537, and K.S.A. 77-542, setting forth the specific grounds upon which relief is sought, to the Commission at 266 N. Main St., Suite 220, Wichita,

Kansas 67202, within 30 days from the date of service of this Order. Hearings will be scheduled only upon written request. <u>Failure to timely request a hearing will result in a waiver of Operator's right to a hearing</u>.

F. A corporation shall appear before the Commission by a Kansas licensed attorney.⁹

G. The Commission retains jurisdiction over the subject matter and the parties for the

purpose of entering such further orders as it may deem necessary.

The information requested above must be submitted on KOLAR. If a U3C Form is returned to you as incomplete, you will not have additional time - the deadline above governs.

Forms must be filed regardless of whether injection occurred. If you became responsible for the well after December 31, 2017, you must still file a U3C Form.
