## **MOTION TO RESCIND ORDER**

The Staff of the State Corporation Commission of the State of Kansas ("Staff" and "Commission," respectively), moves the Commission rescind the Penalty Order in this docket. In support of its motion, Staff states as follows:

- 1. On October 25, 2018, the Commission issued a Penalty Order finding the Operator had committed one violation of K.A.R. 82-3-107 and K.A.R. 82-3-130 because the Operator did not submit a complete and accurate well completion report for the subject well, with the associated documents, within 120 days of the spud date.
  - 2. On November 9, 2018, the Operator timely requested a hearing.
- 3. On November 29, 2018, the Commission issued an Order Designating Prehearing Officer and Setting Prehearing Conference.
- 4. Following the receipt and review of additional information regarding this matter, Staff does not believe expending resources to prosecute this matter is in the best interests of the state.

WHEREFORE, for the reasons set forth above, Staff recommends the Commission rescind its Penalty Order and close the docket.


