NOTICE AND APPLICATION OF
TRANSWORLD NETWORK, CORP. FOR A NAME CHANGE

COMES NOW Transworld Network, Corp. (“TransWorld” or “Company”) and submits this Notice and Application (“Application”) for a change in the Company name to TransWorld Network, LLC on its Certificates of Convenience. In support of this Notice and Application, TransWorld states the following:

1. Applicant was originally authorized to provide resold interexchange and operator services under the name of Strategic Alliances, Inc. (Docket Nos. 93-STAC-184-COC and 93-STAC-477-COC) and notified the Commission on July 28, 1999 that it had changed its name to TransWorld Network, Corp. (Docket No. 00-TWOC-095-CCN).
2. On September 6, 2024 the Company filed a Certificate of Conversion/Domestication with the Kansas Secretary of State changing its name from TransWorld Network, Corp to TransWorld Network, LLC. Included as Exhibit A is a copy of the Certificate of Conversion on file with the Kansas Secretary of State.
3. This name change is transparent to the Company's customers as this is a change in corporate structure only. Customers will continue to be billed under the name TransWorld Network. Additionally, the change in the Company name has no effect on services or rates provided to Company customers.

WHEREFORE TransWorld respectfully requests an Order of the Commission approving this Application reflecting the Company's change of name in all Commission records, including its Certificates of Authority, and all references to the Company at the earliest possible date.

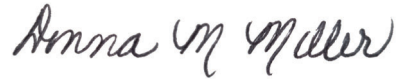

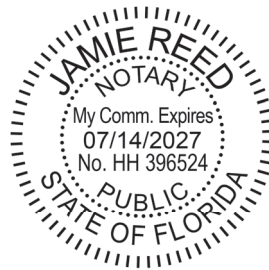
