**ORDER GRANTING ATMOS ENERGY CORPORATION'S
PETITION TO INTERVENE**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed the pleadings and record, the Commission makes the following findings:

1. On March 31, 2023, Kansas Gas Service, a Division of ONE Gas, Inc. (KGS) filed an Application for Approval of Revisions to Certain Tariffs Controlling Transportation Service.
2. On April 12, 2023, Atmos Energy Corporation (Atmos) filed a Petition to Intervene, explaining that as a transportation customer of KGS customers, it may be substantially impacted by this Docket.¹
3. The Commission has broad discretion to grant a petition for intervention if it is in the interest of justice, if the intervention will not impair the orderly and prompt conduct of the proceedings, and if the party has stated facts demonstrating its legal rights, duties and privileges, immunities or other legal interests may be substantially affected by the proceeding.² Furthermore,

at any time during a proceeding, the Commission may impose limitations on an intervenor's participation.³

4. The Commission finds and concludes that Atmos has met the requirements of K.A.R. 82-1-225 and K.S.A. 77-521(b), and should be granted intervention in this Docket.
