SECOND AMENDED APPLICATION
FOR CERTIFICATE OF CONVENIENCE AND NECESSITY

Kansas Gas Service, a Division of ONE Gas, Inc. (“Kansas Gas Service” or “Company”) through this Amended Application requests the Commission issue an Order amending its Certificate of Convenience and Authority to transact the business of a Natural Gas Public Utility within the County of Cherokee, Kansas as further described herein. In support of its Application, Kansas Gas Service states as follows:

1. Kansas Gas Service is a natural gas public utility operating in the State of Kansas pursuant to certificates of convenience and necessity issued by the Commission. Kansas Gas Service’s principal place of business within the state of Kansas is located at 7421 West 129th Street, Overland Park, Kansas 66213.

3. Kansas Gas Service currently serves customers within Cherokee County which includes areas near and adjacent to the city of Baxter Springs. Kansas Gas Service has determined that growth and expansion occurring since the issuance of the Company's original certificates of convenience and necessity (Certificates) for the area has resulted in the need to obtain Commission approval for continued provision of natural gas service in the areas adjacent to but outside of the Company's current certificated service area.

4. On October 30, 2019, Kansas Gas Service filed an *Application for Certificate of Convenience and Necessity* ("Application"), resulting in the establishment of this docket. The original Application requested authority to provide service in areas in the Baxter Springs area that have since been discovered to have already been granted to Kansas Gas Service in the Commission's July 22, 1977, Order issued in KCC Docket No. 112,137 -U.

5. On January 17, 2020, Kansas Gas Service filed an *Amended Application* which contained revisions to the description of the requested service area. This *Second Amended Application* is filed with further corrections and clarification of the description of the requested service area and as is depicted in the associated Exhibit A.

6. The area Kansas Gas Service now seeks authority to provide natural gas service within Cherokee County, Kansas is more specifically described as:

South ½ of the Southeast Quarter Section 34, T34S, R24E; and, the South ½ of the Northeast Quarter of S35, T34S, R24E; and, the South ½ of the Northwest Quarter Section of S36, T34S, R24E; and, West ½ of the NW Quarter Section of S7, T35S, R24E; and, West ½ of the Southwest portions of S7, T35S, R25E; and the North ½ Quarter Section of S18, T35S, R24E as is located in Kansas all in Cherokee County, Kansas.

This request is further depicted as indicated in the chart below:


Further, the requested service area is also described as depicted in the map attached hereto as Exhibit A – Revised 2-4-20.

WHEREFORE, Kansas Gas Service requests that a Certificate of Convenience and Necessity be issued to it granting the right to transact the business of a Natural Gas Public Utility in the above-described territory.
