ORDER GRANTING SUNFLOWER ELECTRIC POWER CORPORATION'S MOTION TO APPROVE ADJUSTMENTS

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and determination. Having reviewed the pleadings and record, the Commission finds and concludes as follows:

- 1. On September 24, 2014, Sunflower Electric Power Corporation (Sunflower) filed its Annual Update with the Commission pursuant to its Open Access Transmission Tariff (OATT) protocols, explaining it had reamortized certain existing debt, extending the debt maturity from December 2016 to December 2033, and effectively lowering Sunflower's annual revenue requirements for the 2015 rate year by reducing principal payment amounts.
- 2. On October 21, 2014, Sunflower filed its Motion to Approve Adjustments to its revenue requirements under its formula-based rate based upon the known and certain amounts submitted in its September 24, 2014 annual update filing.
- 3. The Commission finds that Sunflower's adjustments to the revenue requirements under the formula-based rate will result in just and reasonable rates as required by K.S.A. 66-101b. The adjustments will result in an immediate and quantifiable benefit to ratepayers, therefore, the Commission approves Sunflower's Motion to Approve Adjustments.

THEREFORE, THE COMMISSION ORDERS:

- A. Sunflower's Motion to Approve Adjustments is granted.
- B. The parties have 15 days, plus three days if service is by mail, from the date of service to petition for reconsideration.¹
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
