**NOTICE OF ADJUSTED ONE-TIME CUSTOMER BILL CREDIT AMOUNT**

NOW COMES Kansas City Power & Light Company (“KCP&L” or “the Company”) and,  
for its *Notice of Updated One-Time Customer Bill Credit* (“Notice”), states the following:

1. On October 15, 2018, KCP&L and the other parties to this docket filed a *Joint Motion for Approval of Unanimous Settlement Agreement* (“Settlement Agreement”).

2. In the Settlement Agreement, KCP&L committed to providing a one-time customer bill-credit (“Bill Credit”) relating to tax savings resulting from the Tax Cut and Jobs Act (“TCJA”) (*Settlement Agreement*, ¶ 9). The amount provided in the Settlement Agreement was calculated using an assumed effective date of December 27, 2018 for the new rates.

3. On December 13, 2018, the State Corporation Commission for the State of Kansas (“Commission”) issued its *Order Approving Unanimous Settlement Agreement* (“Order”) with an effective date for the new rates of December 20, 2018.

4. As contemplated in the Settlement Agreement<sup>1</sup> KCP&L has calculated the Bill Credit amount based on the actual date upon which the new rates took effect, December 20, 2018. The adjusted Bill Credit amount to be provided to customers due to TCJA is \$36,301,471.

<sup>1</sup> “If the effective date of new rates from this case is different than December 27, 2018, the amount refunded to customers shall be adjusted to reflect the number of days between January 1, 2018, and the effective date of rates from this case using the annual amount of \$37,354,878 for such calculation.” *Settlement Agreement*, ¶ 9.

WHEREFORE, Kansas City Power & Light Company respectfully requests the Commission take notice of the information contained in this Notice.
