Enclosed for filing, Consolidated Communications of Missouri Company hereby submits the following tariff sheets pursuant to K.S.A. 66-2007(b) with a proposed effective date of June 16, 2023.

The effective date on each sheet has been excluded to allow for proper review and approval by KCC Staff.

The purpose of this filing is to make the following tariff changes:

- Residential access line rate will increase by \$1.50 per month (Current access line rate is \$19.50 increasing to \$21.00)
- Home Phone Standard Service Package will increase by \$2.50 per month
- Voice Advantage and Voice Advantage II bundles will increase by \$2.50 per month (residential access line rate increase of \$1.50 and intrastate long distance minutes' rate increase of \$1.00)

A copy of the bill messaging that will be used to notify customers of these changes is enclosed for your reference. These bill messages will be delivered to customers as part of the March 16, 2023, billing cycle.

On an annual basis, Consolidated Communications of Missouri Company anticipates recognizing approximately \$1,224 in additional residential access line revenue (\$810 from stand-alone access lines and \$414 from access lines in bundles) and \$276 in additional intrastate and interstate long distance revenue resulting from bundled service containing long distance service. These figures do not include estimates of customer churn.
