ORDER CLOSING DOCKET

This matter comes before the State Corporation Commission of the State of Kansas ("Commission") for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

1. On July 17, 2017, Skitter Cable TV, Inc. (Skitter) filed its application for a state-issued Video Service Authorization, as authorized by K.S.A. 12-2023 and K.A.R. 82-15-1.
 2. On August 9, 2017, Skitter filed a Withdrawal of Filing.
 3. The Commission finds and concludes that the closure of the above docket is necessary and proper to promote the State's interest in the efficient administration of Kansas statutes and the Commission's regulations.
 4. The Commission further finds and concludes that, from the record, it does not appear that any party to the matter in this docket will be unduly burdened or prejudiced by the closer of the above docket.
 5. The Commission finds and concludes that the above docket should be closed.

- A. For the reasons set out above, the above captioned docket is hereby closed.


