PRESIDING OFFICER ADDITIONAL ORDER ON COMMISSION STAFF'S JANUARY 28, 2022 MOTION

On January 28, 2022, Commission Staff moved to limit Operator to cross-examination in this docket at any evidentiary hearing before the Commission, and to proceed as if Operator did not file any testimony. Operator had submitted its pre-filed testimony on January 26, 2022, two days late, without a motion to file out-of-time. Staff asked that if such request were not granted, that Staff's rebuttal testimony deadline be extended from February 7 to February 10, 2022.

On February 2, 2022, the Presiding Officer granted Staff's rebuttal-testimony extension request and gave Operator until February 7, 2022, to respond to Staff's request to limit Operator to cross examination/proceed as if Operator did not file testimony. Operator timely responded.

The Presiding Officer notes Operator and its counsel have no identified history of disregarding Commission procedural rules or procedural deadlines in docketed matters, and admitted to having mistakenly and inadvertently failed to request an extension of time. In the present circumstances, the Presiding Officer finds Staff's request to limit Operator disproportionate to the misdeed. Parties are urged to comply with future Commission procedural rules and deadlines. Staff's request to limit Operator to cross-examination and to proceed as if Operator did not file any testimony is denied.
