PETITION FOR RECONSIDERATION OF ORDER ASSESSING COSTS

COMES NOW, Lisa D. Bennett, the Complainant in the above-captioned matter, and pursuant to K.S.A. 77-529(a)(1), respectfully submits the Petition for Reconsideration of the Commission's Order Assessing Costs dated May 8, 2025, and in support thereof states as follows:

1. Background

On May 8, 2025, the State Corporation Commission of the State of Kansas issued an Order Assessing Costs against Kansas Gas Service. A Division of ONE Gas, Inc., In the above-referenced docket.

2. Basis for Reconsideration

Petitioner respectfully requests reconsideration of the order for the following reasons:

The order lacks specific itemization of the costs assessed, making it unclear what expenses exceed the \$100 threshold.

Petitioner request that the Commission provide a detailed breakdown of Investigative and administrative expenses.

Petition also seeks confirmation that no portion of the assessed costs are being redirected to the complainant or improperly levied in violation of K.S.A. 66-1502 and related statutes.

3. Request for Relief

Petitioner respectfully requests that the Commission:

Reconsider and clarify the Order Assessing Costs;

Provide a detailed itemization of the expenses incurred;

Confirm that the complainant is not financially responsible for any portion of these assessed costs;

Grant any further relief the Commission deems just and proper.


