prohibited unless the Commission finds the disclosure is warranted, after considering
all of the factors in that statute. The carrier believes that disclosure of the information
contained in these respective attachments would have a significant and adverse impact
on its competitive stance regarding existing or potential competing entities including
wireless carriers, competitive local exchange carriers, and incumbent local exchange

carriers. Regulatorily mandated disclosure of any or all of the subject information would create a competitive bias in favor of any actual or potential competitor not required to provide comparable information, reducing or eliminating any benefit to consumers otherwise resulting from unbiased competition and damaging the submitting company's ability to engage in fair competition.


