

2. Pursuant to K.S.A. 66-1,129a, 66-1,130 and 66-1,142b, and amendments thereto, the Commission may suspend operations, revoke or amend certificates, and initiate sanctions or fines against every motor carrier and every person who violates any provision of Kansas law in regard to the regulation of such motor carriers and persons, or who fails to obey any order, decision or regulation of the Commission.

3. Pursuant to K.S.A 66-1,115a and 66-1,119, the Commission has the power and authority to authorize a change in a motor carrier's service.

## **II. STAFF'S FINDINGS OF FACTS**

4. On or about March 13, 2015, Verna Jackson of DONALD G. MACFEE, of NORCATUR, KS, submitted a written Request for Abandonment of Certificate of Public Service identified by KSMCID No. 164058. The written request explained that DONALD G. MACFEE is out of business.

5. DONALD G. MACFEE's Certificate of Public Service issued by the Commission on March 30, 2005, authorized operation as a common motor carrier in the transportation of general commodities, other than household goods, passengers or hazardous materials, in intrastate commerce as authorized by K.S.A 66-1,114b.

6. Commission Staff (Staff) has examined its files and records and has not located evidence of unresolved safety concerns, violations or civil penalties associated with the motor carrier's current certificate.

## **III. STAFF'S RECOMMENDATION**

7. Staff recommends that the Commission grant DONALD G. MACFEE Request for Abandonment of Certificate of Public Service identified by KSMCID No. 164058.

## **IV. CONCLUSIONS OF LAW**

8. Based upon the available facts, the Commission finds that Staff's recommendation to grant DONALD G. MACFEE's Request for Abandonment of Certificate of Public Service, is reasonable under the circumstances.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

(A) DONALD G. MACFEE's Request for Abandonment of Certificate of Public Service is hereby granted.

(B) The common operating authority certificate issued to DONALD G. MACFEE on March 30, 2005, identified by KSMCID No. 164058, is hereby cancelled..


(C) A party may file a petition for reconsideration of this Order within thirty (30) days of the date of this Order. If the service is by mail, three (3) additional days may be added to the thirty (30) day time limit to petition for reconsideration. K.S.A. 118b; K.S.A. 66-1,105; K.S.A. 77-529(a)(1).

(D) The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order or orders as it may deem necessary.
