

**REQUEST FOR HEARING**

Christian Martin d/b/a Martin Oil Properties requests a hearing on the denial of its application for renewal of operator license number 3113 and, in support thereof, states and alleges:

1. The Licensee received a letter dated September 20, 2017 from Cyndee Maine, Administrative Assistant at the Kansas Corporation Commission. The letter requested certain information and advised that the Licensee's operator license would be subject to non-renewal if such information was not received.
2. Counsel for the Licensee responded with a letter dated October 2, 2017 and provided relevant information showing that the Licensee's license should not be subject to a denial of renewal.
3. In the October 2, 2017 letter counsel for the Licensee requested a hearing in the event that the application for renewal was denied.
4. By Order dated November 16, 2017 the Commission denied Licensee's application for renewal of its operator license.
5. Licensee disputes the findings and conclusions set out in said Order and alleges that Licensee is qualified and entitled to renewal of its operator license.


WHEREFORE, Licensee Christian Martin d/b/a Martin Oil Properties requests a hearing on the denial of its application for renewal of operator license.
