### ORDER GRANTING CURB'S PETITION FOR RECONSIDERATION

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having examined the files, the Commission finds:

- 1. On July 11, 2013, Westar Energy, Inc. and Kansas Gas and Electric Company (Westar) filed an Application for approval of an Energy Efficiency Rider, which will permit recovery of costs associated with Westar's various energy efficiency programs.
- 2. On July 16, 2013, the Citizens' Utility Ratepayer Board (CURB) filed its Petition to Intervene, citing "[t]he representation of CURB's interests in this proceeding by existing parties is or may be inadequate."
- 3. On August 15, 2013, the Prehearing Officer issued an Order Denying CURB's Petition to Intervene under K.S.A. 77-521(b), finding CURB's Petition to Intervene did not demonstrate a particular interest that is not represented by the other parties affected by the proceeding or identify the specific relief sought by intervention. The Order explained, "[i]f CURB elects to file a new Petition to Intervene, which includes a more detailed demonstration of their interests and explanation of why those interests are not properly represented by other parties

and provides docket-specific facts demonstrating their rights, duties, privileges, immunities, or other legal interests affected by the proceeding and the relief they seek from the Commission, the Commission will revisit the issue."

4. Rather than simply refile a new Petition to Intervene with a more detailed description of their interests and an explanation of why those interests are not properly represented by other parties, on August 20, 2013, CURB filed a Petition for Reconsideration of Prehearing Officer Order Denying CURB's Petition to Intervene and Submittal of Additional Facts Supporting CURB's Petition to Intervene.

5. The Commission finds that by stating the rates paid and the services received by residential and small business customers will or may be affected by this proceeding<sup>2</sup>, CURB has demonstrated an interest in this proceeding. Therefore, pursuant to K.S.A. 77-521, the Commission grants CURB's Petition for Intervention.
