AMENDED JOINT MOTION FOR PROCEDURAL ORDER

Southern Pioneer Electric Company (“Southern Pioneer”), the Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission”, respectively), the Citizens’ Utility Ratepayers Board (“CURB”), National Beef Packing Company, LLC (“National Beef”), and Air Products and Chemicals, Inc. (“Air Products”) (collectively referred to as “Joint Movants”) hereby move the Commission for an Order establishing a procedural schedule in the above-captioned matter. In support of this motion, Joint Movants state the following:

1. On January 31, 2024, Southern Pioneer filed its Application pursuant to K.S.A. 66-117 seeking approval of its Renewable Energy Program Rider (“RE Rider”).
2. On February 2, 2024, CURB filed a petition to intervene, which was granted on February 8, 2024. On February 14, 2024, National Beef and Air Products filed petitions to intervene, which were both granted on March 12, 2024.
3. Joint Movants conferred to develop a procedural schedule for this docket to propose to the Commission for consideration. That proposed agreed schedule is as follows:
