ORDER CLOSING DOCKET

The above-captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having reviewed its files and records and being duly advised in the premises, the Commission makes the following findings:

- 1. On June 10, 2021, the Commission issued an Order to Show Cause (Show Cause Order) in this proceeding. The Order to Show Cause required Tru Mobility, Inc. (Tru) to respond within thirty (30) days to (1) show cause why it should not be subject to penalties and fines for violating K.S.A. 66- 2008(a); (2) comply with its Kansas Universal Service Fund (KUSF) obligations; and (3) pay its \$5,678.26 in outstanding assessment contributions and \$11,076.71 in outstanding administrative penalties.¹
 - 2. On June 28 2021 and July 22, 2021, Tru filed responses to the Commission's Order.
- 3. On April 8, 2022, Staff filed an R&R, recommending the Commission: (1) find Tru non-compliant with the Commission's Show Cause Order; (2) find that Tru owes \$4,274.37 of assessment contributions and \$13,495.66 of penalties to the KUSF; (3) deny Tru's requests to remit

monthly payments and waive or reduce its KUSF penalties; (4) direct Vantage Point Solutions (VPS) to stop accruing additional penalties for Tru; and (5) give Tru 45 days to pay its delinquent KUSF balance before the Commission initiates collection actions against the Company.²

- 4. On April 28, 2022, the Commission issued an Order Assessing Penalties for Failure to Comply with K.S.A. 66-2008(a) (Penalty Order) adopting Staff's findings and ordering Tru to pay \$4,274.37 of assessment contributions and \$13,495.66 of penalties to the KUSF within 45 days.³
- 5. Staff filed a series of Notices of Filings Vantage Point Solutions' Memorandums tracking Tru's payments on August 29, 2022, August 31, 2022, April 12, 2023, July 12, 2023, August 14, 2023 and November 21, 2023. In the most recent filing, VPS stated Tru had paid its KUSF balance in full and is now current with its KUSF obligations. VPS further recommended that the docket be closed.
- 6. The Commission determines the findings and recommendation of VPS to be reasonable and hereby adopts the same.

IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:

- A. This docket is hereby closed based on Vantage Point Solution's Memorandum of November 17, 2023, stating Tru Mobility, Inc has now paid its KUSF balance in full and is now current with its KUSF obligations.
- B. Any party may file and serve a petition for reconsideration pursuant to the requirements and time limits established by K.S.A. 77-529(a)(1).⁴
