**ORDER CLOSING DOCKET**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds the following:

1.       On September 25, 2019, Little Chief Energy Corporation (Operator) filed an Application seeking authorization for injection of saltwater at its Stafford lease.<sup>1</sup>
2.       On October 16, 2019, Rick and Karen Lindesmith (Protesters) filed a protest.<sup>2</sup>
3.       On November 19, 2019, Protesters withdrew their protest.<sup>3</sup>
4.       Because Protesters have withdrawn their protest, the Commission finds further proceedings are unnecessary.

**THEREFORE, THE COMMISSION ORDERS:**

- A.       This docket is closed.
- B.       Commission Staff may review Operator's Application administratively and may grant the Application if appropriate.<sup>4</sup> If any issue arises necessitating the reopening of this docket, then any party may request such at any time.


