NOTICE OF APPLICATION FOR HORIZONTAL WELLBORE

TO: ALL OIL AND GAS PRODUCERS AND OWNERS OF UNLEASED MINERALS AND WHOMSOEVER CONCERNED:

You, and each of you are hereby notified that Cherokee Wells, LLC has filed an application before the State Corporation Commission (the "Application") to permit the drilling of a well known as the K. Claiborne D3-1H well (the "Well"), having a deviation in the well bore exceeding 7 degrees in the Bartlesville formation upon certain lands in Wilson County, Kansas, at the following location:

Surface Location of approximately 1,000' from the South line ("FSL") and 1,699' from the East line ("FEL") of Section 1, Township 27 South, Range 15 East; Entrance into the producing formation at approximately 188' FSL and 1,957' FEL of Section 12, Township 27 South, Range 15 East; and a bottom hole location of approximately 989' from the North line and 2,329' FEL of Section 12, Township 27 South, Range 15 East.

You are further notified that any person who objects to such well must file a written protest to the Application with the State Corporation Commission Conservation Division, at the 266 N. Main St., Suite 220, Wichita, Kansas 67202 within fifteen (15) days after publication of this Notice. The protest shall state the specific reasons why the drilling of the Well in the manner and at the locations set forth in the Application will cause waste or violate correlative rights. No hearing will be held in connection with this matter unless a valid protest is filed or the Kansas Corporation Commission on its own motion deems there should be hearing on this Application.

All parties in any way interested or concerned shall take notice of the foregoing and govern themselves accordingly.
