# **AMENDED APPLICATION**

COMES NOW, Merit Energy Company, LLC, 13727 Noel Road, Suite 1200, Dallas, Texas 75240, Applicant herein and respectfully states to the Commission as follows:

1. The Applicant is the owner of oil and gas leasehold interests and operates wells in the Hugoton Panoma Gas Fields in Finney County, Kansas.

2. The Applicant desires to drill the Reeve 2 well at a location 925 feet from the South line and 290 feet from the West line in the SW/4 of Section 14, Township 25 South, Range 33 West, Finney County, Kansas, which is the unit boundary.

3. Applicant desires to drill the Reeve 2 well at that location in order to gain the most advantageous geological position and to assure reservoir availability at that location.

4. Applicant requests an exception pursuant to K.A.R. 82-3-108 in order to allow the drilling of this well closer than 330 feet from the nearest lease or unit boundary, to prevent waste without violating correlative rights.

5. Attached hereto and made a part of this Application, marked Exhibit "1", is a tabular listing of the names and addresses of each offset operator whose lease line is located less than 330 feet from the proposed location, and each of the unleased offset mineral owner whose property boundary is within 330 feet of the proposed location, and the Applicant's lessor/lessors located within 330 feet from the proposed well location.

6. Applicant has sent by regular mail a copy of this Application and Notice to all persons listed on the attached Exhibit "1."

7. Attached to this Application as "Exhibit B" is plat map showing the location of the subject well proposed for a location exception, and all pertinent wells within one-half (1/2) mile of the subject well.

8. The acreage to be attributable to the well will be the 10 acres surrounding the well and Applicant requests the well be assigned a full allowable.

9. That Applicant is causing Notice of this pending Application to be published as required by the Commission, in *The Wichita Eagle* and *The Garden City Telegram* newspapers. Said notice provides that unless written protest is received by the Commission within fifteen (15) days after the date of publication of said notice, the Applicant in this matter will be granted administrative approval of the Application after the 15 day period.

WHEREFORE, Applicant prays that this cause be docketed and in the event that no protest is made to the Commission within the time period provided, an Order be entered granting the well location exception of the Reeve 2 well.


