# PRESIDING OFFICER ORDER DIRECTING OPERATOR TO SHOW CAUSE

On July 15, 2025, the Presiding Officer issued an order setting a procedural schedule, establishing a September 12, 2025, deadline for Operator to submit its pre-filed testimony.

Operator did not submit any pre-filed testimony by the deadline. Instead, after the Presiding Officer emailed counsels on September 22, 2025, regarding a proposed hearing date, Operator submitted pre-filed testimony on September 25, 2025. Operator's counsel has not responded to the email, has not otherwise communicated with the Presiding Officer, and in violation of the Commission's May 22, 2025, Order Designating Presiding Officer and Setting Prehearing Conference, Operator did not accompany its late-filed testimony with a motion to file out-of-time.<sup>1</sup>

Operator is directed to show cause why its pre-filed testimony should not be stricken as untimely. The filing showing any such cause is due by October 1, 2025.
