YOU, and each of you, are hereby notified that Tapstone Energy, Inc., has filed an Application with the State Corporation Commission of the State of Kansas requesting an Order for the assignment of allowable at the appropriate time and a location exception to the Diel Farms 31-33-8 1H well with a bottom hole location 330 feet from the South Unit line and 1980 feet of the East Unit line in Section 31, Township 33 South, Range 8 West, Harper County, Kansas. The exception is being requested because the bottom hole will be closer than 660 feet from the nearest producing well in the same production zone.

YOU are further notified that the Applicant will complete the well in the Mississippi formation, and requests assignment of a full allowable to the Diel Farms 31-33-8 1H well.
