JOINT MOTION FOR PROCEDURAL SCHEDULE

Kansas Gas Service, a Division of ONE Gas, Inc. ("Kansas Gas Service"), the Staff of the Kansas Corporation Commission ("Staff" and "Commission," respectively) and the Citizens' Utility Ratepayers Board ("CURB"), collectively referred to as the "Parties," request the Commission grant this Joint Motion for Procedural Schedule ("Joint Motion"). In support of the Joint Motion, the Parties state as follows:


1. On June 26, 2018, Kansas Gas Service filed an application with the Commission for approval of an adjustment of its natural gas rates.
2. On July 16, 2018, CURB filed its petition to intervene in this matter.
3. The Parties have discussed a proposed procedural schedule in this docket and were able to reach agreement on a schedule that could be recommended to the Commission for its review and approval. The Parties have also agreed to allow CURB's witness to appear at the scheduled Evidentiary Hearing on December 13, 2018, because of a scheduling conflict. The Parties also discussed with Advisory Counsel, Brian G. Fedotin, the proposed procedural schedule.




