MOTION RECOMMENDING PROPOSED PROCEDURAL SCHEDULE

Staff of the Kansas Corporation Commission (Staff and Commission, respectively) moves for the Commission to adopt the proposed procedural schedule. In support of its motion, Staff states the following:

- 1. On January 21, 2025, Commission Staff filed a Motion for the Designation of a Presiding Officer and the Scheduling of a Prehearing Conference regarding around 54 Request for Change of Operator (T-1) forms which were submitted to transfer wells from Daylight Petroleum, LLC (Daylight) to Bluejacket Operating, LLC (Bluejacket). The T-1 forms did not include 11 wells on the Johnson lease or the Olnhausen Farms #6, which caused an abandoned well to break out on the Johnson lease.
- 2. On February 20, 2025, the Commission held a hearing in Docket 25-CONS-3040-CMSC (Docket 25-3040) regarding the abandoned well that Daylight's operations caused to break out beneath a building on the Johnson lease. Since that docket is related to this docket, Commission Staff respectfully requests that any procedural schedule to prefile testimony or briefs in this matter be determined after the Final Order is issued by the Commission in Docket 25-3040. Staff believes that it is possible that this matter could be resolved without the need for the development of a procedural schedule depending on the Final Order issued by the Commission.

3. Commission Staff recommends the following deadlines for the Commission's

consideration.

Commission Staff Pre-filed Direct Testimony/Brief Due 30 days after the

Final Order issued by the Commission in Docket 25-3040

Daylight/Bluejacket Pre-filed Direct & Rebuttal Testimony/Response Brief

Due 14 days after Commission Staff's filing

Commission Staff's Pre-filed Rebuttal Testimony/Response Brief Due 14

days after Daylight/Bluejacket's filing

WHEREFORE, for the reasons described above, Staff respectfully requests the

Commission issue an Order adopting the procedural schedule recommended by Commission

Staff in this matter.
