AMENDED APPLICATION

COMES NOW Grand Mesa Operating Company (Applicant) in support of
its amended application in the captioned matter and states as follows:

1. Applicant is a Corporation authorized to do business in the State of Kansas.
Applicant's address is 1700 N. Waterfront Pkwy, B600, Wichita, Kansas 67206.
2. Applicant has been issued by the Kansas Corporation Commission Operator's License #9855, which expires on August 30, 2025.
3. Applicant is the owner and operator of the Baumfalk 4 (a/k/a Drift Unit #20) well, API #15-153-20684-00-01 (the subject well), which is located in the NW/4 of Section 22, Township 1 South, Range 33 West, Rawlins County, Kansas. The subject well is located in an active oil and gas unit for enhanced recovery operations of the following lands in Rawlins County, Kansas: S W/4 of Section 15, E/2 SW/4, S/2 NE/4 and SE/4 of Section 16, NE/4 of Section 21 and NW/4 of Section 22, Township 1 South, Range 33 West, containing 800.0 acres, more or less (leased premises).
4. Pursuant to K.A.R. 82-3-111, the well was shut in, or Applicant obtained temporary abandonment status, for the subject well on May 01, 2004. The subject well

has maintained such status from May 01, 2004, to the present date.

5. On or about April 15th, 2025, the Kansas Corporation Commission notified Applicant temporary abandonment status for the subject well would be denied after April 15th, 2025, because subject well has been temporarily abandoned for more than ten (10) years. Applicant acquired operations from Thresher Energy starting 2/1/25.

6. K.A.R. 82-3-111 imposes a 10-year limitation on the amount of time during which wells may be temporarily abandoned, but an exception to the 10-year limitation may be obtained pursuant to said regulation through an application filed with the Commission pursuant to K.A.R. 82-3-100. Applicant seeks such an exception.

7. On April 15, 2025, the subject well passed a Commission Staff-witnessed mechanical integrity test of the casing between the surface and the CIBP set @ 3800'.

8. Applicant wishes to continue TA status for the subject well, because Applicant intends to use the well for potentially resuming injection support or to re-evaluate to be recompleted as a producer.

9. Applicant submits the following information regarding the well in support of the Amended Application:

- a. The Drift Unit lease consists of the following wells:
17 Oil wells
4 WIW,s
1 WSW
3 TA'd
- b. Estimated cost to P&A the Baumfalk 4 - \$31,500
- c. Current lease production rate- 3 BOPD. The Drift Unit did produce 7-11 BOPD back in August – November 2024.

- d. There is an estimated 43,000 BBLS remaining reserves, after resuming production to 2024 levels. Redesign consideration to the waterflood will improve recovery.
- e. Lines are already in place for the well, it will need a workover to remove CIBP, acidize and run equipment.

10. Applicant has included a plat map showing the location of all producing, injection, temporarily abandoned, abandoned, and plugged wells located in the same area as the subject well.

11. Based on the foregoing, Applicant requests the Commission grant an exception to the 10-year limitation, specifically to allow the subject well to remain eligible for temporary abandonment status for three (3) years following the expiration of the 10-year limitation. Applicant understands that the exception would be valid for three (3) years, but Applicant would still need to apply annually to the Conservation Division District Office for approval of an application for temporary abandonment status.

12. Listed in the attached Exhibit "A" are the names and addresses of the following persons:

- A. Each operator of each oil and gas lease covering lands within one-half (1/2) mile radius of the subject well; and
- B. Each person who owns any mineral interests of record in and under any lands located within one-half (1/2) mile radius of subject well
(Provided that such material interests is not covered by any oil and gas lease).

13. Notice of this Amended Application will be published pursuant to K.A.R. 82-3-135a. In addition, notice of the hearing to be held in this manner will be provided as prescribed by K.A.R. 82-3-135.

WHEREFORE, Applicant prays that this matter be granted administratively without a hearing, or in the alternative be set for hearing, and upon hearing that the Commission grant Applicant's request, for an exception to the K.A.R. 82-3-111 ten (10) year limitation, to allow the subject well to remain temporarily abandoned for three (3) years, subject to annual approval by the Conservation Division District Office of an amended application for temporary abandonment status.




