### **ORDER DESIGNATING PRESIDING OFFICER**

This matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. The Commission finds the following:

- 1. On April 28, 2021, Western Cooperative Electric Association, Inc. (Western) filed an application to update its Local Access Delivery Service (LADS) tariff.<sup>1</sup> Western seeks to increase the LADS demand charge assessed to wholesale users of its 34.5kV system from \$0.96 per kW to \$1.64 per kW, a 70.85% increase, in accordance with the 34.5kV Formula Based Rate plan approved in Docket No. 21-SEPE-049-TAR.<sup>2</sup>
- 2. At this time, pursuant to K.S.A. 77-551(c), the Commission finds that a Presiding Officer should be designated in this proceeding to address any matters listed in K.S.A. 77-517(b).
- 3. The Presiding Officer in the prehearing matters shall be Phoenix Anshutz, Assistant General Counsel, Kansas Corporation Commission, 1500 SW Arrowhead Road,
