
1. On July 24, 2018, the Staff of the State Corporation Commission filed its Report and Recommendation regarding required compliance filings pursuant to Commission Order in Docket No. 15-WSEE-211-COM.

2. On August 16, 2018 the Commission granted CURB intervention in the above mentioned docket.

3. On February 28, 2020, Evergy Metro, Inc. d/b/a Evergy Kansas Metro [f/k/a Kansas City Power & Light Company] ("Evergy Kansas Metro"), Evergy Kansas Central, Inc. [f/k/a Westar Energy, Inc.] and Evergy Kansas South, Inc. [f/k/a Kansas Gas and Electric Company] (collectively referred to herein as "Evergy Kansas Central") filed a Confidential Annual Report of Damage Claims for Structure Fires.
