**ORDER CLOSING DOCKET**

This matter comes before the State Corporation Commission of the State of Kansas (Commission). Having examined its files and records, and being fully advised in the premises, the Commission finds and concludes as follows:

1. On December 6, 2016, Commission Staff (Staff) issued a Notice of Denial of License Renewal Application to Mid-America Pipeline Company, LLC (Operator), stating that individuals associated with Operator are also associated with an entity not in compliance with Commission statutes, regulations and orders.

2. On December 14, 2016, Operator timely filed its request for a hearing in this matter.

3. On January 26, 2017, Staff filed a Motion to Close Docket, stating that all matters regarding the renewal of Operator's license have been resolved to Staff's satisfaction, and Staff no longer wishes to contest Operator's license renewal application. Staff noted it has processed Operator's application, and Operator's license has been renewed. Thus, Staff requested the docket be closed.

4. Based on Staff's Motion, the Commission affirms Staff's review and resolution of the issues concerning Operator's license renewal application. The Commission is satisfied with

Staff's administrative processing and renewal of Operator's license. Thus, the Commission finds the matter is appropriately resolved, and this docket should be closed.


**THEREFORE, THE COMMISSION ORDERS:**

- A. The docket is closed.
- B. Parties have 15 days, plus three days if mailed service, from the date this Order was served in which to petition the Commission for reconsideration.<sup>1</sup>
- C. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it deems necessary.
