In the Matter of the Audit of TWC Digital Phone LLC by the Kansas Universal Service Fund (KUSF) Administrator Pursuant to K.S.A. 2014 Supp. 66-2010(b) for KUSF Operating Year 18, Fiscal Year March 2014-February 2015.

Dear Ms. Green:

On July 12, 2016, the Kansas Corporation Commission (KCC or Commission) issued an Order adopting GVNW Consulting, Inc.'s (GVNW) Audit Report and directed TWC Digital Phone LLC (TWC Digital or Company) to: 1) to submit Quarterly True-ups within forty-five (45) days of the end of each KUSF quarter; and 2) file within thirty (30) days from the data of the Order, an affidavit executed by an officer of the company attesting to and explaining TWC Digital's inability to identify revenues related to discounts.

On August 25, 2016, TWC Digital submitted a notarized affidavit attesting that the Company cannot reasonably identify revenue related to discounts because the revenues that are booked to the general ledger are net revenues. TWC Digital affirmed that the Company does not have a reasonable method of reporting based on gross revenues.

TWC Digital, on October 19, 2016, filed a supplemental officer affidavit that noted the Company does not track gross revenue in its general ledger, but for compliance purposes, it calculated the estimated gross revenues related to discounts by using certain bill presentment information for the period March 2014 - September 2015. TWC Digital provided True-ups showing an additional \$18,688.74 owed to the KUSF. Based on the review of the information provided to GVNW and Staff, the additional assessment owed to the KUSF is a reasonable approximation for the purposes of this audit docket.

On October 27 15, 2016, 2016, TWC Digital paid the additional \$12,789.58 in assessments to the KUSF. The Company elected to net a \$5,899.16 credit to offset the amount owed to the KUSF. Accordingly, GVNW recommends that Docket No. 16-TWCZ-029-KSF be closed.
