**ORDER APPROVING CERTIFICATE**

The above captioned matter comes before the State Corporation Commission of the State of Kansas (Commission) for consideration and decision. Having examined its files and records, and being duly advised in the premises, the Commission finds and concludes as follows:

1. In its Order of April 30, 1984, in Docket No. 127,140-U, the Commission found that resellers were public utilities and subject to Commission regulation. As part of that regulation, the Commission directed resellers of telecommunications services to file applications for Certificates of Convenience and Authority and accompanying tariffs for approval.

2. In its Order of March 21, 1994, in Docket No. 187,168-U, the Commission adopted revised streamlined rules and regulations governing resellers and interexchange carriers, designed to reflect changes occurring in the marketplace.

3. On June 2, 2008, Wildflower Telecommunications, LLC (Wildflower) filed an application to provide long distance, toll telecommunications, resold operator and interexchange services within the State of Kansas. No party or company has filed an intervention in this proceeding.

4. On September 16, 2008, the Commission Staff (Staff) filed a memorandum recommending Commission approval of this application.

5. Wildflower proposes to provide long distance, toll telecommunications, resold operator and interexchange services within the state of Kansas. After reviewing Wildflower's biographical, key personnel, and financial data, Staff believes Wildflower has the managerial and financial resources necessary to provide interexchange and operator services in the State of Kansas. Staff also believes the general public would benefit from Commission approval of this application.

6. Wildflower is properly registered with the Kansas Secretary of State's Office. Wildflower is "active and in good standing" with the Kansas Secretary of State's Office.

7. Wildflower is reminded to notify the Commission immediately of any change in address or contact telephone numbers.

8. The Commission, therefore, finds and concludes that Wildflower should be granted the authority requested in this docket, without a public hearing, subject to all other rules, regulations, or statutes governing the Wildflower, in particular those set out in Docket Nos. 187,168-U and 120,408-U.

**IT IS, THEREFORE, BY THE COMMISSION ORDERED THAT:**

A. The Application of Wildflower Telecommunications, LLC for a Certificate of Convenience and Authority to resell interexchange and operator services in Kansas is hereby granted.

B. Wildflower Telecommunications, LLC is reminded of its obligations to file annual reports with the Commission and pay its Commission and Kansas Universal Service Fund assessments, and remain current with the Kansas Secretary of State's Office. The failure to fulfill any of these obligations could result in the revocation of Wildflower Telecommunication, LLC's Certificate.

C. The parties have fifteen days, plus three days if service of this Order is by mail, from the date this Order was issued in which to petition the Commission for reconsideration of any issues decided herein. K.S.A. 66-118b; K.S.A. 2007 Supp. 77-529.

D. The Commission retains jurisdiction over the subject matter and the parties for the purpose of entering such further order, or orders, as it may deem necessary.
