- 1. On September 21, 2016, Commission Staff issued a Notice of Denial of License Renewal Application pursuant to K.S.A. 55-155(c)(4) stating that individuals associated with Operator are associated with entities that are not in compliance with Commission regulations.
  - 2. On September 23, 2016, Operator filed a request for hearing in this matter.
- On September 29, 2016, the Commission issued its Order Designating Prehearing
   Officer & Setting Prehearing Conference. The prehearing conference was held on October 6,
   2016.
- 4. On October 13, 2016, Commission Staff moved the Commission to close this docket. After conducting informal discovery, Staff no longer wishes to contest Operator's license renewal application. Staff has processed the application, and Operator's license has been renewed. Since this matter has now been resolved, Staff asks for the docket to be closed. Staff has conversed with Operator, which is not opposed to Staffs motion.

5. The Commission finds and concludes that the proceedings in this matter should be cancelled, and the docket should be closed.

## THEREFORE, THE COMMISSION ORDERS:

- A. The proceedings in this matter are cancelled, and this docket shall be closed.
- B. The Commission retains jurisdiction over the subject matter and parties for the purpose of entering such further orders as it may deem necessary.
