## **APPLICATION**

COMES NOW Running Foxes Petroleum Inc. for its application in the above captioned matter states as follows:

- Operator is a corporation authorized to do business in the State of Kansas.
   Operator's address is 1690 155<sup>th</sup> St, Ft. Scott, State of Kansas and 14550 East Easter Ave.,
   Ste 200, Centennial, State of Colorado, 80112
- 2. Operator has been issued by the Kansas Corporation Commission Operator's License #34318, which expires 4/30/2023.
  - 3. Operator is the owner and operator of the Vogel #10-36C INJ 2
- 4. well, API #15-011-23901-00-00 ("the subject well"), which is located in the Northeast Quarter of the Southwest Quarter of the Northwest Quarter of the Southeast Quarter of Section 36, Township 24 South, Range 23 East, Bourbon County, Kansas. The subject well comprises the following lands:

Southeast Quarter of Section 36, Township 24 South, Range 23 East, Bourbon County, Kansas, containing 160 acres, more or less ("leased premises")

- 5. Pursuant to K.A.R. 82-3-407(a) the subject well is being maintained in a manner that will prevent pollution of fresh and usable water, prevent damage to sources of oil or gas, and confine fluids to the intervals approved for injection.
- 6. Pursuant to K.A.R. 82-3-407 the subject well was scheduled for a Mechanical Integrity Test (MIT) on January 20, 2023. The Mechanical Integrity Test was witnessed by Chuck Large (Running Foxes Petroleum) and Ryan Tromsness (KCC). A copy of the Form U-7 is attached. It was later determined that MIT was performed on a well that was not the Subject Well. An MIT was conducted on the Subject Well on February 15, 2023. The operator did not receive the letter sent by the Commission Staff on January 20, 2023, to bring the Subject Well into compliance by February 3, 2023, deadline.
  - 7. Our finds of facts is the wrong well was MITed.
- 8. Once the it was realized the we MITed the wrong well, the right well was MITed on February 15<sup>th</sup>.
  - 9. We feel this is an honest mistake and we request the fine be set aside.
- 10. Listed in the attached Exhibit "A' are the name and addresses of the following persons:
  - A. Each Operator on the lease, there are no other Operators within 1/2/mile; and

B. Each person who owns any minerals interest of record in and under any lands located on the lease (provided that such mineral interest is not covered by any oil and gas lease).
