**JOINT MOTION FOR CONTINUANCE**

COMES NOW, Midwest Energy, Inc. (“MIDWEST”), the Citizens’ Utility Ratepayer Board (“CURB”) and the Staff of the State Corporation Commission of the State of Kansas (“Staff” and “Commission” respectfully) and jointly move the Commission for a continuance of the evidentiary hearing in the above captioned matter from June 17-18, 2008 until June 23, 2008 at 1:30 p.m. In support of said motion, the parties state the following:


1. On February 25, 2008, the Commission issued an Order Granting Intervention to CURB and Establishing Procedural Schedule. In that order, an evidentiary hearing was scheduled for June 17, 2008.
2. The February 25, 2008 order established June 4, 2008 and June 5, 2008 as dates for settlement conferences. The parties met at that time, but were unable to agree on settlement terms. Since that time, the parties have continued to work towards settlement.
3. The parties have reached terms for a unanimous settlement in the above captioned case. The parties are now working to reduce the terms of the agreement to writing. The parties intend to file a Stipulation and Agreement on or before June 16, 2008.

4. Midwest and Staff plan to file testimony to support the Stipulation and Agreement. CURB has agreed to the settlement terms and will sign the Stipulation and Agreement, but does not plan to file testimony in support of the Stipulation and Agreement. Staff and Midwest will file testimony supporting the Stipulation and Agreement on or before Wednesday, June 18, 2008.

5. The parties have agreed and in consultation with Charles Reimer, Advisory Counsel, request that the hearing in the above captioned matter be continued until Monday, June 23, 2008 at 1:30 p.m.

WHEREFORE, for the reasons stated above, Midwest Energy, Inc., the Citizens' Utility Ratepayer Board, and Staff of the State Corporation Commission of the State of Kansas jointly request the Commission continue the hearing in the above captioned matter from June 17, 2008, until June 23, 2008, at 1:30 p.m.
