ORDER RESCINDING PENALTY

Upon its own motion, the Commission finds and concludes as follows:

I. FINDINGS OF FACT

1. On June 2, 2015, the Commission issued a Penalty Order in this docket, requiring

Operator to pay \$100 for one violation of K.A.R. 82-3-409, and requiring Operator to submit a

U3C Form for the Hayes #4 well. On June 12, 2015, Operator filed a timely appeal.

2. Staff reports that Operator did not submit the U3C Form by March 1, 2015, as

called for by K.A.R. 82-3-409, and that Staff did not receive the U3C Form by April 30, 2015, as called for in Staff's Notice of Violation letter. However, Staff notes that Operator filed the 53 other U3C Forms that were requested in Staff's Notice of Violation letter by the April 30, 2015, deadline, and that Operator avers that the U3C Form at issue was submitted at the same time. Operator submitted a copy of the U3C Form along with its appeal.

3. Given Operator's record of compliance and the facts described above, Staff recommends rescission of the penalty order.

II. CONCLUSIONS OF LAW

4. Based upon the above, the Commission concludes that the June 2, 2015, Penalty

Order in this docket should be rescinded.

THEREFORE, THE COMMISSION ORDERS:

A. The Penalty Order issued in this docket is rescinded.
