- 4. Any person requiring special accommodations under the Americans with Disabilities Act should notify the Commission at least 10 days before the scheduled hearing date.
- 5. Any party who fails to attend or participate in the evidentiary hearing or any other stage of this proceeding may be held in default under the Kansas Administrative Procedure Act.<sup>1</sup>
  - 6. Parties shall appear before the Commission via a Kansas-licensed attorney.<sup>2</sup>
